



## Test Session Participant Requirements due to COVID-19

1. The rink area **only** will be closed to the public during the test session. All other areas of the facility will remain under direction of the facility management. The test session will be treated as a private event in the rink area, this will allow the Central Florida Figure Skating Club (CFFSC) to host this U.S. Figure Skating (USFS) sanctioned test session while following the USFS, CDC as well as state and local county requirements.
2. The test session on January 10, 2021, is being hosted at the following location:

Orange County
3. This facility is located in a county with an emergency ordinance that requires face coverings. Additional information can be found on the county website.
4. Test Session participation requires acceptance of these requirements. Participation in this test session is voluntary and as such you are able to opt-out prior to the day of the test session and receive a refund of entry fees. Failure to comply on the day of test session will result in being unable to test and fees will not be refunded.
5. All Volunteers, Coaches and Staff must be 18+ years of age and must adhere to all safety guidelines for this event.
6. CFFSC will conduct temperature checks of all test session participants including skaters, coaches and chaperones.
7. Skaters should arrive ready for the test, fully dressed, hard guards on, and ready to walk onto their warm-up for the test. Locker rooms will NOT be available and will not be monitored or cleaned by CFFSC as these are deemed public areas by the facility.
8. All skaters, chaperones and coaches must wait for their warm-up time in their cars or outside of the rink area.
9. Only the skater, the skater's primary Coach, and two (2) Chaperones (parents or guardian) per skater, Judges, test session volunteers and rink staff will be permitted in the rink area during the test session.
10. A mask covering both the nose and mouth are required to worn by all and at all times. Skaters will be permitted to remove their masks once they are on the ice. Skater must re-mask upon leaving the ice and exit the rink area, immediately. This will enable CFFSC volunteers to disinfect and prepare for the next testing group.
11. Designated waiting areas for the coach and skater inside the rink area will be socially distanced and you will be asked to remain in this area.
12. Chaperone(s) will be treated as spectators and given access to a socially distance areas to watch **ONLY** their skaters test session.
13. After each group of skaters are tested, any designated areas as well the ice entry point will be cleaned to disinfect touch points.

14. Test results will be text/emailed to the coach as soon as they are available. Test result sheets and the patches will be provided to the coach for distribution at a later time.
15. Restricted areas for Judges and test staff members will be clearly marked. Skaters, coaches, and chaperones will not be allowed to enter.

**Test Session Waiver of Liability:**

1. I agree that I am personally responsible for my safety and actions while attending the January 10, 2021 Test Session at RDV Ice Den. I agree to comply with all CFFSC policies and rule, including but not limited to all CFFSC policies, guidelines, signage, and instructions. I have read the Test Session Participation Requirements due to Covid-19 adopted as policy by the CFFSC and agree to comply with all items.
2. Because the RDV Ice Den is open for use by other individuals, I recognize that I am at higher risk of contracting COVID-19. With full awareness and appreciation of the risks involved, I, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby forever release, waive, discharge, and covenant not to sue the Central Florida Figure Skating Club, its board members, officers, agents, servants, independent contractors, affiliates, employees, successors, and assigns from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by me related to COVID-19 and the participation requirements.
3. **Anyone attending the test session rinkside (beyond the lobby double doors) is required to sign this waiver. If a skater or anyone in his/her family cannot sign the waiver or refuses to adhere to the policies contained therein, the skater’s test session fees will be refunded. Reasonable accommodations under the ADA will be allowed on a case-by-case basis, which may include asking people to wear face shields or watch skaters test from the lobby.**
